Approve Minutes: Louis Vilardo

January 12, 2009 – Bob Bittenbinder made a motion to approve the minutes. Wayne Hatten seconded the motion. Dave Mastran abstained. Bob Bittenbinder, Wayne Hatten, Mary Ann Martin, Jim Moore and Louis Vilardo were in favor, and the motion passed.

Blas Contreras arrived at 7:06.

Old Business

- Update on New Bank Search Mary Ann Martin Mary Ann recommended TD. When she visited Anchor, there was yet a different communication than in the past. Mary Ann said TD is the only bank that has provided a written proposal of their services. Bob Bittenbinder made a motion to move the account from Anchor to TD. Wayne Hatten seconded the motion. All were in favor, and the motion passed unanimously.
- Outsourcing of Violation Inspection
 Louis Vilardo read a quote Kathy Green submitted after contacting a couple of vendors to inspect for violations. The quotes were \$1600/month and \$500/month. Due to the high cost, the Board decided not to pursue outsourcing at this time.

❖ New Business

- Increase in Property Crime Louis Vilardo
 Louis reported that activity such as robbery and vandalism was on the rise in the
 community. Bob Bittenbinder recommended the speed traps were the sheriff's
 responsibility, and the funds could be used to patrol for crime. It was agreed to maintain
 the \$4000 budget and determine exactly how it would be used at a later time.
- Discussion and Approval of "Covenant Enforcement" Letter Louis Vilardo
 Louis distributed copies of a Covenant Enforcement letter addressed to Juno Isles
 homeowners. The Board agreed for the letter to be submitted to the attorney for review.
- Website Enhancement and Maintenance Louis Vilardo
 Pete Lashenka has been maintaining the JICA website on a voluntary basis. He indicated
 to Louis, due to a job promotion, he would be unable to continue maintaining the website.
 Louis asked Pete to remove the outdated information and give access to a Board member.
 Pete said the requirements would be a software purchase of approximately \$400 and a
 steep learning curve to utilize it. Louis acquired a quote from two web design companies
 of approximately \$2500 to redesign the website and allow the Board to easily maintain it
 in the future.

Old Business

- Louis recommended that when Mary Ann Martin opens new bank accounts, open a separate account for the \$6600 collected several years ago toward a lighting project on Ellison Wilson Road and Juno Isles Blvd. Wayne Hatten made a motion to return \$20 to each homeowner as a deduction from their annual assessment. Blas Contreras suggested the lighting issue be raised again. Dave Mastran seconded the motion. Wayne Hatten and Mary Ann Martin were in favor. Bob Bittenbinder, Blas Contreras, Dave Mastran, Jim Moore and Louis Vilardo were opposed. Homeowners will not receive a refund. Bob Bittenbinder made a motion to create a separate bank account for the funds collected for lighting. Louis Vilardo seconded the motion. All were in favor, and the motion passed unanimously.
- Approve 2009 Budget
 Options to balance the budget and/or adjust annual fees were discussed. The budget was
 balanced, and it was agreed that the annual fee would remain \$100.00.

Wayne Hatten left at 8:25.

Bob Bittenbinder made a motion to accept the budget as amended. Blas Contreras seconded the motion. All were in favor, and the motion passed unanimously.
